This component is defined as a safety component according to MD 2006/ 42/ EC Annex V (17). No procedure referred to article 12(3) and (4) exists for this component. This component is not defined in Annex IV, therefore according Annex VIII / 12 (2) is valid. There is no particular harmonized norm existing to announce this conformity. As the requirements for this safety component are comparable to the requirements according to the Lift Directive 2014/33/EU, we announce the conformity therefore. Special features of the design of the machinery according to MD 2006/ 42/ EC in opposite to the Directive 2014/33/EU has to be described in the Risk Analysis of the machinery.
